Storage		Supplied in 10 mM NaH ₂ PO ₄ , 150 mM NaCl, 0.09% NaN ₃ , 0.1% gelatin, pH7.2. This product is stable fo 6 months when stored at 4° C. Do not aliquot the antibody. Protect from light. Do not freeze.
Specificity/Sensitivity		The antibody is not directed against any known antigen. It functions as an isotype control for mouse monoclonal antibodies.
Description		This Cell Signaling Technology antibody is conjugated to PerCP-Cy5.5 $^{\circledR}$ under optimal conditions and tested in-house for direct flow cytometric analysis in human cells.
Background		Isotype control antibodies are used to estimate the nonspecific binding of target primary antibodies due to F_c receptor binding or other protein-protein interactions. An isotype control antibody should have the same immunoglobulin type and be used at the same concentration as the test antibody.
Species Reactivity		Species reactivity is determined by testing in at least one approved application (e.g., western blot).
