<b>Specificity/Sensitivity</b>	The antibody is not directed against any known antigen. It functions as an isotype control for rat monoclonal antibodies.	
<b>Description</b>	This Cell Signaling Technology antibody is conjugated to PE under optimal conditions and tested in-house for direct flow cytometric analysis in mouse cells.
