Mouse His₆ Tumor Necrosis Factor- α (mHis₆TNF- α)

Background

TNF- α , the prototypical member of the TNF protein superfamily, is a homotrimeric type-II membrane protein (1,2). Membrane bound TNF- α is cleaved by the metalloprotease TACE/ADAM17 to generate a soluble homotrimer (2). Both membrane and soluble forms of TNF- α are biologically active. TNF- α is produced by a variety of immune cells including T cells, B cells, NK cells and macrophages (1). Cellular response to TNF- α is mediated through interaction with receptors TNF-R1 and TNF-R2 and results in activation of pathways that favor both cell survival and apoptosis depending on the cell type and biological context. Activation of kinase pathways (including JNK, ERK (p44/42), p38 MAPK and NF- κ B) promotes the survival of cells, while TNF- α mediated activation of caspase-8 leads to programmed cell death (1,2). TNF- α plays a key regulatory role in inflammation and host defense against bacterial infection, notably *Mycobacterium tuberculosis* (3).

Endotoxin

Less than 0.01 ng endotoxin/1 μ g mHis₆TNF- α .

Purity

>98% as determined by SDS-PAGE of 6 μ g reduced (+) and non-reduced (-) recombinant mHis₆TNF- α . All lots are greater than 98% pure.

Source / Purification

Recombinant mouseHis₆ TNF- α (mHis₆TNF- α) Leu80-Leu235 (Accession #NP_038721) was expressed in human 293 cells at Cell Signaling Technology.

Bioactivity

The bioactivity of recombinant mHis₆TNF- α was determined in a L-929 cell viability assay. The ED₅₀ of each lot is between 10-40 pg/ml.
